In view of representations received from prospective bidders regarding error faced while uploading bid documents in the E-procurement Portal ([www.assamtenders.gov.in](http://www.assamtenders.gov.in)), bidders may note the following-

During on-line bid submission, if the bidder is unable to upload the consolidated soft copy of the Technical Bid (Pre-Qualification Bid Format, Technical Bid Format, etc.) as prescribed; due to Technical Error if faced by prospective bidders as mentioned above, the following procedure will be followed-

- A. The bidder will submit the soft copy of the Pre-Qualification Bid Format during on-line bid submission. Thereafter, the bidder will have to submit the complete set of the Technical Bid [Receipt copy of online payment of Tender Processing Fee, EMD(Receipt of online payment/ Bank Guarantee/ Corporate Guarantee), Pre-Qualification Bid, Technical Bid] on a CD/DVD along with the mandated physical copy of the bid to the Office of the Managing Director, Guwahati Smart City Limited, 4<sup>th</sup> Floor, Aditya Tower, Opposite Down Town Hospital, G S Road, Guwahati 781006 on or before the due date for physical submission of bid documents.
- B. In case of the aforementioned scenario under A above, the bidder will maintain the same sequence for the Pre-Qualification Bid Format and the Technical Bid Format as specified in the RFP in both the CV/DVD and the physical copy of the bid document submitted.
- C. The bidder will enclose a hard copy of the snapshot of the error displayed while uploading.
- D. Further, the Financial Bid will have to be submitted online as per the requirements set in the RFP.
