Minutes of the Technical Committee for the Project "Brahmaputra Riverfront Development Project under GSCL" held in the office chamber of Guwahati Smart City Limited on 23.12.2021 at 02:00 PM

The deliberations of the meeting are as follows:

Guwahati Smart city Limited (GSCL) invited bids through e-Procurement portal for the work "Development of Brahmaputra Riverfront from New DC Bungalow to Kachari Ghat on Design, Build and Operate for 5 years basis in Guwahati" for an estimated cost of Rs.308.80 Crore (Tender no. SPV/GSCL/DEV/61/2017/Pt-II/80 and tender Id. 2021_GSCT_23114_1). The tender was published through e-Procurement portal on 4-10-2021 as well as in leading local and national news papers. Subsequently, the Bid submission date was extended twice for 15 (fifteen) days each to ensure more participation of bidders in the subject tender.

Despite allowing 60 days time for bid submission, single bid was received; M/s GSCO-HSEA had submitted bid for the subject tender. Since a single bid has been received even after sufficient submission time and wide publicity, the tender committee in its meeting on 07/12/2021 recommended opening of Technical Bid based on the recent circular of Ministry of Finance, Department of Expenditure, Procurement Policy Division, Govt. of India vide Circular No.F.1/1/2021-PPD, dated 29/10/2021, Clause 11.8, Page-9.

During technical Evaluation following short comings are noticed in the bid submitted by M/s GSCO-HSEA, with respect to the requirements set forth in the Tender documents:

- 1. One of the partner of the JV, M/s HSEA with 49% financial stake do not have Average Annual Construction Turnover, as required vide Clause No. 1.2.2.
- 2. Project experience of both the partners are insufficient and do not fulfill tender requirement, as required vide Clause No. 1.3.
- 3. Bidders were asked to submit preliminary design in their proposal but the bidder did not submit any design in their technical bid, as required vide Clause No. 2.

The Bidder is found non-responsive in most of the Pre Qualifying Criteria and hence, the Tender Committee recommend to cancel the Tender and go for Rebidding.
