2.	Clause No.4.5 Project Key Resource Profiles Sl No.5: Financial & Procurement Expert	MBA Finance is allowed
3.	Clause No. 5.14: Consortium Bids	<p>Joint Venture/ Consortium of 2 are allowed. All the Members of the JV shall be jointly and severally responsible for this Contract. The Member of the JV holding highest stake shall be the Lead Partner.</p> <p>A Joint Venture Agreement must be submitted along with the BID in which minimum share of Lead member shall not be less than 51% and share of other member, individually shall not be less than 20%.</p> <p>Lead bidder should be technically qualified as per the RFP requirements.</p>
4.	Clause No. 3.16: Blacklisting	The Firm should not be blacklisted as on date of time of submission of the bids.
5.	Clause No.4.5 Technical Evaluation Criteria (Marking Criteria)	Original RFP conditions shall prevail.
