1. <u>Techno-commercial Eligibility Criteria:</u>

- A. The constitution of the Applicant, whether Individual/ Proprietary Firm/ Partnership Firm/ Registered Company, must be clearly stated and relevant documents like partnership deed/ Memorandum of association & Article of Association etc. must be submitted. If the Applicant is an individual, the application shall be signed by him above his full type written name and current address.
- B. The EOI application must be signed by a person holding the power of attorney or an authorityletter of the power of attorney holder of the Applicant's entity – authority-letter and power of attorney must be submitted.
- C. The Applicant must be registered under GST and shall submit necessary proof of the same along with the PAN card.
- D. Previous work Experience of Similar Nature in last five years.
- E. Valid 3rd Party Inspection report of the equipments must also be submitted with the proposal.
- F. The prospective applicant is advised to visit the site of work, if and when required, at his own cost, and examine it and its surroundings to collect all information that he considers necessary for proper assessment of the prospective assignment.
