1.0 Introduction to Guwahati Smart City Limited

The Government of India has announced creation of 100 Smart cities to drive economic growth and improve the quality of life of people by enabling local development and harnessing technology as a means to create smart outcomes for citizens. Guwahati is one of the shortlisted cities for the smart city initiative under Ministry of Urban Development, Government of India. Guwahati Smart City Limited (GSCL), a special purpose vehicle (SPV) was created to plan, design, implement, coordinate and monitor the smart city projects in Guwahati City. GSCL is a company incorporated under Indian Companies Act 2013 with equal shareholding from Govt. of Assam.

2.0 Objective of this competition

GSCL, as part of its mission to drive economic well being and improve the quality of the life of the citizens of Guwahati city will continuously strive to harness technology for innovative and smart solutions.

In spirit of the aforesaid, GSCL for the first time organising a competition amongst the start-up firm based in the State to provide ICT based solutions in the Health Care domain.

The solution to be provided by the participants should be comprehensive in nature and should have minimum lead time to roll out with a sound business model apart from other aspects.

3.0 Selection Process & Rewards

- GSCL shall constitute a Committee of experts to evaluate the overall proposal submitted by the Start-up firms. The decision of the Committee shall be binding.
- The selection Committee shall rank three best solutions as per the proposal submitted by them and accordingly monetary awards shall also be given to the best three solutions.

4.0 Eligibility for Participation

- i) Constitution: The firm must be a recognised legal entity in the form of a registered company or a registered partnership firm promoted by local entrepreneurs of the State of Assam with its registered office at Assam.
- ii) Compliance:
 - a) The firm must have to full fill the definition of the Start Up firm as per the definition of the Start Up Policy of the Government of India
 - b) The firm must have office in the State with minimum 5 employees
 - c) The firm must have all valid statutory documents

- d) Board of director details/partners details for a partnership firm
- e) Firm must not be blacklisted by any State and Central Government agencies and departments and also should not have any legal case pending in any court of the country.
- f) Participating firm has to submit the details as mentioned in Annexure-1 & 2 along with their proposal.
- g) The proposal must be submitted within the stipulated time duly signed by the chief promoter/ MD of the firm or in case of the partnership firm by one of the partners.

5.0 Key feature

- i) The submitted solutions shall not be a mere idea but must have the potential to make it sound business model to support the idea.
- ii) The solutions so submitted should be clearly establish its revenue stream to work on a PPP model.
- iii) The technology platform must be a robust one to cater the demand and flexible enough to integrate other service providers in the health care domain.

7.0 Implementation model of the solution proposed

The firm must be able to provide in their proposal a detail plan to implement the solution covering the entire Guwahati City. Below are the few points which are indicative only and details can be provided here (within 2000 words max)

- a) Design, development and deployment of the solution proposed
- b) Forward and back ward integration proposed
- c) Capacity Building requirements
- d) Marketing plan and brand building
- e) Support mechanism at various levels in 24X7 mode
- f) Challenges in rolling out the application including competition in the market
- g) Time of rolling out the solution in the Guwahati City
- h) Support expected from GSCL
- i) Any other point

8.0 Business and Financial Model

The firm participating in the Competition needs to understand that the solution proposed should have clear financial road map with profitability and able to share the revenue from the first three month with GSCL.

Thus, firm must be able to indicate a financial model which is techno-commercially feasible and able to share part of its revenue with GSCL for a three-year period indicating

- a) Proposed revenue stream from the various sources
- b) Expenditure to be incurred in
 - i) Development and maintenance cost of the solutions
 - ii) Forward and Backward integration cost
 - iii) Proposed Manpower cost
 - iv) Marketing expenses
 - ii) Capacity building expenses
 - iii) Any other expenses



It may be noted that any model which fails to provide the required financial viability shall not be accepted.
