- (*) The minimum value of items at Sl. No. (a) & (c) above shall be considered at 2020-2021 Price Level. Weightage of 5% per year over the previous years will be given on compounding basis.
- (#) Similar completed works shall mean Civil Construction involving Electrical and Landscaping/Horticulture works.
- 3. - 4. The bids submitted by the bidders who do not meet the qualification requirements as required or whose Bids (both Technical and Price) are not complete are not valid. Earnest Money of the tenders containing restricted validity of Bids is liable to be forfeited. The bids not accompanied by Earnest Money Deposit shall be rejected.
- 5. Issue/ download of Tender Documents to/ by the bidder will not automatically mean that the bidder is qualified for the Award of the Contract. The bidders will be required to fulfill the Qualification Criteria given in the Tender Document before being considered eligible for the Award of Contract. No Condition/ Deviation which is either additional or in modification of the tender conditions shall be included in the bid submitted by the bidder. If the bid contains any

such conditions or deviations from the tender conditions, the bid will be rejected.
